FIRM DESCRIPTION

Selwood Asset Management LLP ("Selwood") is a London based FCA authorized independent asset manager that was established in 2015 by Sofiane Gharred. Selwood manages over \$1.8 billion assets, with a focus on delivering consistent returns through a variety of hedged and trading focused equity and credit strategies.

INVESTMENT OBJECTIVE & STRATEGY DESCRIPTION

Selwood Asset Management LLP launched an equity European-focused fund with low net exposure, namely the Selwood Equity Absolute Return UCITS Fund ("Fund") on the Investcorp-Tages UCITS platform in April 2022. The investment objective of the Fund is to seek to achieve long term capital growth by investing or seeking exposure primarily to European companies.

The Fund seeks to achieve the investment objective by investing on a long and/or short basis in equities and equity-related securities, either directly or indirectly through the use of FDI. The equities and equity-related securities in which the Fund may take exposure to include common shares, preference shares and depositary receipts. The Fund will primarily invest in companies with a market capitalization of greater than USD 1 billion, including (without limitation) mid capitalization companies (USD 2-10 billion) and some large capitalization companies (greater and USD 10 billion).

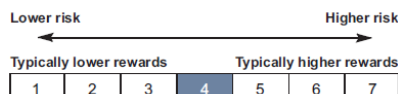

COMMENTARY

Equity markets enjoyed their best October in twenty years, possibly at a time when hardly anyone expected it. Bond yields initially moved higher, before retracing quite sharply relative to the highs of the month, led by the UK. Despite the ongoing hawkish talk from Central Bankers, pivot hopes combined with bearish positioning, oversold technical conditions, and CTA buying drove stocks higher.

Every sector finished the month positive in Europe. Travel & Leisure was top of the pile (+15%), whilst Food & Beverages were small up at the bottom of the list.

The Fund finished the month up +2.63% in what was arguably a very challenging period, particularly on the short side of the book. Indeed, in the last month Morgan Stanley's European basket of the most shorted stocks has outperformed the Stoxx 600 by 10%. In the last decade the one-month outperformance of that basket has only been higher once, right at the Covid lows.

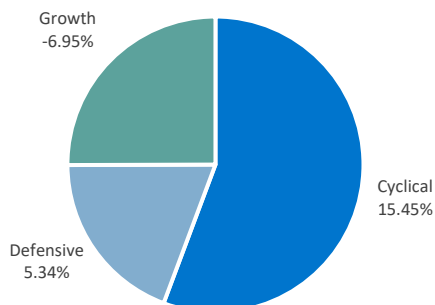

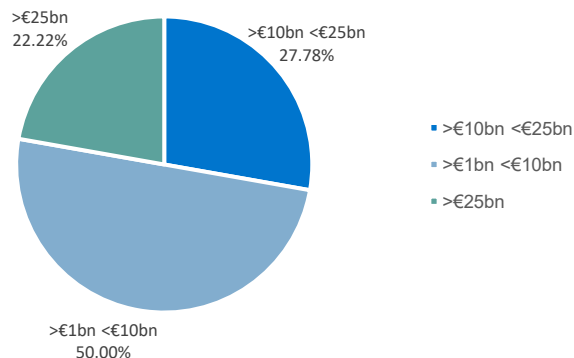
PORTFOLIO EXPOSURES

RISK GLOSSARY

Credit and Counterparty Risk: The Sub-Fund will be exposed to a credit risk in relation to the counterparties with whom it transacts or places margin or collateral in respect of transactions in derivatives. To the extent that a counterparty defaults on its obligations and the Sub-Fund is delayed or prevented from exercising its rights with respect to the investments in its portfolio, it may experience a decline in the value of its position, lose income and incur costs associated with asserting its rights.
