### OBJECTIVES AND INVESTMENT POLICY

#### Investment Objective

The investment objective of the Sub-Fund is to achieve positive risk adjusted returns.

#### Investment Policy

The Sub-Fund will seek to achieve its investment objective by focusing on companies which are, or have the potential to be involved in event driven situations such as mergers and acquisitions arbitrage, large asset disposals, restructuring, special situations and other similar event driven situations events (commonly referred to as "Event Driven Situations").

The Sub-Fund will invest in equities (i.e. shares of companies) equity-related securities (i.e. securities which have the potential to convert into a share of a company) and equity indices (an index measures the price of a basket of securities using a standardized metric and methodology) and bonds (i.e. a debt instrument that represents a loan made by an issuer to a borrower). The Sub-Fund may gain exposure to commodities through exchange traded commodities ("ETCs") or interest rates. The Sub-Fund may also gain exposure to contingent value rights ("CVRs") (i.e. financial instruments such as shares that are issued as part of the consideration paid to the shareholders of companies being acquired in merger and acquisition transactions) and special purpose acquisition companies or "SPACs", which are publicly listed special purpose acquisition companies with the specific purpose of acquiring a private company.

The Sub-Fund's investments will primarily be focussed on companies incorporated in or whose principal economic activity arises in global developed markets. However, the Sub-Fund may also invest in emerging markets.

The Sub-Fund may invest directly or use derivatives, such as options, swaps, credit default swaps, futures, warrants and equity rights, to gain indirect exposure to investments. A derivative is a contract the value of which depends on the change in price of an agreed-upon underlying financial asset, index or security. The Sub-Fund may use indices to gain indirect exposure to equities and any such investment will be made indirectly through index derivatives, such as options, swaps, credit default swaps and futures.

The Sub-Fund can take short positions in any asset class through derivatives, as well as hedging its exposure to an asset class by using derivatives to take an offsetting long or short exposure to the same or another asset class. In broad terms, long positions mean that the Sub-Fund will benefit if prices go up but lose if prices go down. Short positions mean the Sub-Fund will make a profit if the value of the investment goes down, but it will lose money if the value of the

investment goes up, unless the loss is capped or offset by another investment. Under normal market conditions, it is expected that the value of the long positions held by the Sub-Fund shall not exceed 200% of the Net Asset Value of the Sub-Fund at any one time and it is expected that at any given time the maximum of the absolute values of the short positions of the Sub-Fund shall not exceed 150% of the Net Asset Value of the Sub-Fund.

The Sub-Fund may also invest up to 15% of its Net Asset Value in real estate investment trusts ("REITS") which are listed or traded on a Recognised Market. A REIT is established as a trust or partnership structure which uses pooled capital of many investors to purchase and manage income property. For the avoidance of doubt, investment in REITS will be classified as an investment in transferable securities.

In addition, the Sub-Fund may invest in open-ended exchange traded funds and other open ended collective investment schemes which provide exposures consistent with the above. Investment in open-ended funds will be limited to 10% of the Net Asset Value.

The Sub-Fund may, in certain circumstances, invest up to 100% of its Net Asset Value in cash, cash equivalents, bonds and money market instruments for cash management purposes.

Melqart Asset Management (UK) Limited acts as the sub-investment manager of the Sub-Fund.

#### Benchmark

The Sub-Fund is actively managed, meaning the Investment Manager actively selects and invests the securities in which the Sub-Fund invests with the aim of meeting the investment objective of the Sub-Fund, and is not managed with reference to a benchmark or index.

#### Subscription and Redemption

You may sell your shares in the Sub-Fund any day that banks are open in Dublin, Ireland and London, United Kingdom. You must submit your application to the Sub-Fund's Administrator before 1.00 p.m. three business days before the day on which you want to sell.

#### Income

Your shares do not pay income, but instead the Sub-Fund reinvests such income to grow your capital.

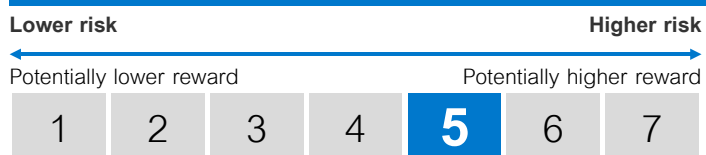
#### Fund Currency

As your shares are denominated in USD and the Sub-Fund is valued in EUR, forward contracts are used to attempt to eliminate the effects of changes in the currency exchange rates against EUR.

#### Investment Horizon

Recommendation: the Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### RISK AND REWARD PROFILE



#### Why is this Sub-Fund in this category?

The risk category for this Sub-Fund is set at 5. It is calculated in line with EU regulations and is based on the risk limit for the Sub-Fund.

#### Risk Disclaimer

A **category 1** Sub-Fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **category 7** Sub-Fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex. For example, a category 2 Sub-Fund is not twice as risky as a category 1 Sub-Fund. The risk category shown is not guaranteed and may change over time.

**When categorising the Sub-Fund, it may happen that not all material risks were fully captured in the methodology:**

**Short Selling Risk:** The Sub-Fund may create synthetic short positions through the use of derivatives. Short positions behave differently from long positions, and the Sub-Fund can for example come under pressure to close out short positions at short notice, and before an offsetting long position can mature. This can create unexpected losses from positions that might otherwise have been seen as low risk or well hedged.

**Credit Risk and Counterparty Risk:** The Sub-Fund will be exposed to a credit risk in relation to the counterparties with whom it transacts or places margin or collateral in respect of transactions in FDI. To the extent that a counterparty defaults on its obligation and the Sub-Fund is delayed or prevented from exercising its rights with respect to the investments in its portfolio, it may experience a decline in the value of its position, lose income and incur costs associated with asserting its rights.

**Derivatives and Leverage Risk:** Leverage arises from entering into derivatives, the terms of which can have the effect of magnifying an outcome, meaning the profits and losses from an investment can be greater than if the investment is made directly into the underlying securities.

**Emerging Markets Risk:** Emerging markets that are at an early stage of development typically experience higher levels of return fluctuation than well-established economies. Political and economic challenges may temporarily result in illiquid markets, higher volatility, higher inflation, less protection of assets and less developed laws to protect investors.

**Event Driven Strategies:** Event driven investing requires the Sub-Investment Manager to make predictions about (i) the likelihood that an event will occur and (ii) the impact such event will have on the value of a company's securities. Losses can result if the Sub-Investment Manager's predictions are incorrect. Event driven investing is speculative and performance results can fluctuate.

**SPACs:** A SPAC is a publicly listed special purpose acquisition company with the specific purpose of acquiring a private company (a

"Transaction"). SPACs are subject to significant "event risk"; that is, a SPAC's success depends on its ability to identify and close a Transaction. If a SPAC fails to close a Transaction it is typically required to liquidate and dissolve.

**REITS:** REITS may be affected by changes in the value of the underlying property owned by the trusts. Equity REITS are dependent

upon management skills, may not be diversified and are subject to the risks of financing projects. Such trusts are also subject to heavy cash flow dependency and self-liquidation. The ability to trade REITS in the secondary market can be more limited than other stocks.

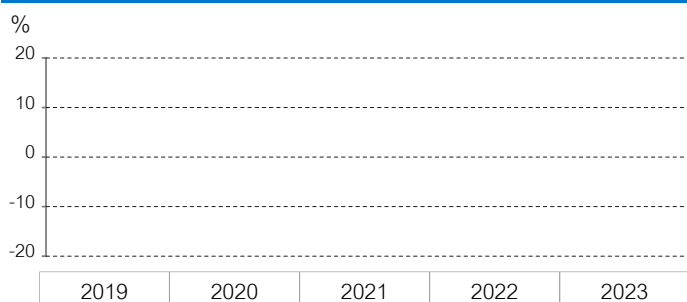
